VIII. CSA Report

• Mr. Capone discussed the Grab and go program; the board had approved at the last meeting. Our percentage of participation was 29% overall, there was a 2/3 reduction in the free/reduced families that were able to participate. Overall number for the free/reduced meals was 7%. The families that are not free and reduced and picked up meals was 22%. There has been a lot of comments about this program from the community. Members in the community are spreading misinformation and advocating for federal fraud for the district and the parents. As per USDA guidance, only parents or guardians can pick food for students. This is not a mandatory program, there was no requirement to deliver. We did deliver, insuring our free and reduced students were getting their meals.

- A Quote from a vendor has been given to the board, this is not a complete evaluation of the building just to give the board an idea what the cost will look like.
- Mr. Plotsky makes the board aware of what is being discussed is that the, County Board is telling us we cannot reopen until we have more information. It will cost us \$45,000 to obtain that information for the whole building spot checking.

• Mr. Teufert stated the building is safe, as the state must inspect it.

Mr. Brislin motioned to ask Edison energy to revise their proposal for an evaluation of the whole building and to obtain a second quote of the whole building.
