- 6. CSA REPORT James Andriac, CSA State testing starts on Monday, May 5, 2025. Please have the students at school on time. Our track team has two meets on Thursday and Friday. Thursday is at Sparta and Friday is at Newton. Our FFA students are at the Agriscience Fair at Rutgers to compete. We had one HIB that was founded. We went through the full investigation and discipline was taken according to our handbook. Mr. Andriac thanked Ms. Coppolino and Mr. Romano for all their hard work for the State testing.
- **7. PRESIDENT'S REPORT Andree Campbell -** Both Ms. Campbell and Ms. Statkus attended STEM night. The kids were very excited. Ms. Campbell attended the township committee meeting.

8. SBA REPORT - Presentation on the 2025-2026 Budget

Mr. Bussow gave the public publication to the township. He went over the budget process. Reviewed 2024-2025 grant funded improvements, capital projects and school accomplishments. Discussed 2025-26 budget with detailed revenues and expenditures. Focused on programs, building projects, state aid and tax impact. We have money available to us because we have not utilized our full tax increases the past few years and we are not accessing that this year. We are taking a weighted increase for enrollment increases which we have not taken and are going with a 2% increase so there's an 8% eligible increase that we are leaving on the table from money that we have not asked for in prior years. We are just asking for the enrollment adjustment with a 2% increase and the State allows the \$141,000 adjustment for healthcare which is a portion of the Title 43 program that they have for how we manage our healthcare costs. Our staff contributes to their healthcare and we pay a large part to their healthcare. That increases substantially each year and the State is allowing us to to retrieve a little bit of that from the tax levy. The total tax levy is \$7.8 million.

Mr. Andriac stated that more kids will go to HP instead of Tech because we have been working with HP now with our sports. It costs more for students to go to HP than Tech.

Ms. Statkus stated that there is a sizable difference between what the estimated about is and what the tax rate will be and what is unfortunate for the board is that we have to get a budget approved before the assessor has to submit their information so we won't actually know what the effect is going to be on everybody's taxes until the assessor does his job in July. The reason the tax rate has dropped is because according to the State of New Jersey, the value of land in Montague has gone up significantly over the last couple of years so that's why we need to raise more money and taxes. It looks like the rate is dropping but the rate would only drop if we were assessed at the correct amount which the STate of New Jersey says we are not.

Mr. Bussow said our budget is based on last October's report to the State. The valuation rate is also based on October's report to the State.

There was a brief discussion about the MD rooms for next year.
