Additionally, since 2015 there have been ongoing reports of continual harassment at meetings and on school grounds. Therefore, as a safety precaution for the Board Members, Administration, public and students, the presence of the Constable has been requested at the meetings until these threats cease to exist.

CSA Report

Robert Walker discussed an incident that occurred recently at the school involving an obscene gesture. Tacia Johnson questioned the appropriateness of discussing the incident before it was discussed in Executive Session because of the potential legal impact. Gary Kraemer stated that since it happened in public it could be discussed in public.

At a basketball game, a community member was alleged to have given another community member an obscene gesture. The event was reported to the CSA and he along with the Assistant Principal addressed the matter with the individual. The individual was told to stop any activity that could be construed as an obscene gesture or it would be possible for legal action to be taken. A letter was also sent to the individual to memorialize the conversation. Additionally, the school's insurance broker was notified of the event as was the NJ State Police. The additional notification was done to ensure the school's liability was reduced and demonstrate the school's commitment to maintaining a safe environment for all students.

Mr. Walker also reported that Dr. S. Ripley of High Point Regional High School had requested a 5:30pm late bus for Montague students. Diane Cole and Linda Spinapolice both stated that a 5:30pm late bus was supposed to be in place already. The Business Administrator will look into after-school busing and report back to the Board.

Public Session

As a reminder for all, and as per NJSBA, Board of Education meetings are "a meeting in public, not a meeting of the public. Many people, especially parents and community members, misunderstand the nature of a school board meeting. School boards provide leadership for what are typically multi-million dollar corporations. The board has important work to accomplish. And, to do that work, the board needs to be fully engaged around the table. The Open Meetings Act requires that public business be done in public, and that citizens have opportunity to observe and comment at every meeting."

Additionally, as per NJSA 2C:33-8, 10:4-12, and as adopted by Montague's Board of Education in Bylaw 9322.1, please remember the public participation shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface by an announcement of his/her name, place of residence, and group affiliation if appropriate;
- 2. Each statement by a participant shall be limited to 3 minute duration
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard;
- 4. All statements shall be directed to the presiding officer; no participant may address or question Board Members individually;
- 5. The presiding officer may:
 - a. Interrupt, warn, or terminate a participant's statement when the statement is too lengthy, abusive, obscene, or irrelevant;

- b. Request any individual to leave the meeting when that person does not observe reasonable decorum;
- c. Request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
- d. Call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action; and
- e. Waive these rules when necessary for the protection of privacy or the efficient administration of the Board's business.

During this portion of the meeting, the residents are invited to address the Board with any comments or concerns that may be in respect to the operation of their school.
